

Waiver and Agreement to Hold Harmless

I, the undersigned, have enrolled myself and my dog(s) in private dog training classes, seminar and/or board & train program offered by Off Leash Columbia, LLC. I understand that participation in Off Leash Columbia, LLC's private sessions, seminars and board & train are not without some risk, that despite all the dogs appearing healthy, and being handled with the greatest amount of care and foresight, dogs are not always predictable and the unexpected may occur such as injuries, allergic reactions, consuming foreign objects, and hot spots. I hereby assume any and all risks that would customarily and ordinarily occur by my participation in dog handling, dog movement or activities onsite, and consent to a release to the benefit of Off Leash Columbia, LLC in consideration for my acceptance and participation in the program. I hereby waive and release Off Leash Columbia, LLC, its employees, contractors, owners and agents, of any and all claims while on the grounds or surrounding area thereto, and resulting from participation in Off Leash Columbia, LLC training including specifically, but without limitation, any injury or damage resulting from the action of any dog, including my own. I further agree to pay veterinary / medical expenses incurred as a result of injury caused by my dog(s). I give Off Leash Columbia, LLC permission to seek veterinary care if necessary for my dog(s) at my sole expense, including flea or pest treatment, oral medication, or procedures requiring anesthesia. However, I will not hold Off Leash Columbia, LLC responsible if they fail to seek veterinary care.

Board and Train: Any dog entering Off Leash Columbia, LLC's training programs must be up to date on relevant vaccinations such as rabies and DHPP. Owners must supply 30lbs of dry dog food or a charge of \$30 will be assessed for food purchase. In the event of an emergency, Off Leash Columbia, LLC is authorized to spend up to \$600 for veterinary/clinic services at the owner's expense. Off Leash Columbia, LLC is not responsible for injuries or irritations resulting from dog's own behavior while boarding such as scratching or attempting to escape from kennel, etc. Owners cancelling a Board and Train reservation within 3 days of their scheduled drop off date will be charged a \$200 reschedule fee. **Scheduling is of the utmost importance to our operation. An owner who has not retrieved their dog after 14 days will be charged \$150 per day boarding fee.**

Off Leash Columbia, LLC may use pictures of me or my dog for publicity or promotional purposes of "Off Leash Columbia, LLC" without liability or obligation of any kind to me; however no information/pictures can be sold or shared otherwise without additional consent.

I recognize the role I play in my dog's learning process is **integral** to achieving desired results especially after formal training is completed. I understand and agree continued daily e-collar practice and repetition are needed to solidify and reinforce the training for my dog. I acknowledge and agree that there is no guarantee that my dog will achieve the desired level of training or be cured of its behavior issues, despite the best efforts of the instructor. All training packages training will be paid for in full no later than 60 days beyond the beginning of training for Basic and Advanced packages and by conclusion of training for Board and Trains.

I hereby declare that I am of legal age and competent to sign this agreement. I understand this agreement. I agree to be bound by it. I have read the policies here and on the website www.OLK9columbia.com for dog training and I agree to adhere to them.
